SUBJ.: 2014 Apartment Building Agreement Benefit increases/decreases with Local 32BJ, SEIU

BENEFITS:

The 2014 Apartment Building Agreement provides for Benefit Increases/decreases effective **January 1, 2015** as follows:

- a) **Health Fund:** increased \$15.00 per week to \$1,297.88 per month
- b) **Pension Fund:** increased \$4.00 per week to \$98.75 per week
- c) **Supplemental Retirement & Savings Fund (SRSF):**
No change, remains at \$10.00 per week
- d) **Training Fund:** No change, remains at \$169.60 per year
- e) **Legal Fund:** increased to \$199.60 per year for 2015.
